RIGHT OF WAY TECHNICIAN (LABORER)

The entry level position performs assigned duties as required by the Foreman related to the handling of tools, materials, and necessary equipment in the support of the Right Of Way Department. This position will report to the Right Of Way Foreman.

Essential Duties: Operates equipment, performs maintenance, controls traffic, maintains tools, signals operators, gathers and removes litter, trimmings, etc., operates shredding and chipping equipment, uses hand tools, prunes and cuts trees, shrubs, etc., and other duties as assigned.

Education/Experience Requirements: High school diploma or general education degree (GED) preferred; or one (1) to three (3) months related experience and/or training; or equivalent combination of education and experience. Outside work experience preferred. A valid driver license is required. A valid commercial driver license is preferred. If not, must be able to obtain within ninety (90) days of hire, upon supervisor's direction.

Job Requirements: While performing the duties of this Job, the employee is regularly required to sit and talk or hear. The employee is frequently required to stand; walk; use hands to finger, handle, or feel; reach with hands and arms and stoop, kneel, crouch, or crawl. The employee is occasionally required to climb or balance. The employee must occasionally lift and/or move up to 100 pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception and ability to adjust focus.
